NOTES

1. You must pay at least as much or more UK income tax and/or capital gains tax (for the year of the donation) as the amount that will be claimed by The Smallpeice Trust and any other charities and CASCs (Community Amateur Sports Clubs) you donate to during each tax year. You will be responsible for any shortfall of tax.
2. Basic rate tax is currently 20 per cent, so this means that if you give £10 using Gift Aid, it's worth £12.50 to each charity you donate to.
3. If you pay higher rate tax, you can claim the difference between the higher rate of tax 40 and/or 45 per cent and the basic rate of tax 20 per cent on the total 'gross' value of your donation to the charity or CASC. For example, if you pay 40% tax and donate £100, the total value of your donation to the charity is £125 - and you can claim back £25. If you pay tax at 45 per cent you can claim back £31.25.
4. You can cancel this declaration at any time by notifying the charity.
5. If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that each charity you donate to reclaims, you must cancel your declaration (see note 1)
6. If you pay tax at a higher rate you can claim further tax relief in your Self-Assessment tax return.
7. If you are unsure whether your donations qualify for Gift Aid tax relief, ask the charity (tel: 01926 333210).
